

# Consignor Agreement and Release

**This agreement is made between Scarlet Threads Boutique and you, the Consignor. In order to participate and benefit from the Scarlet Threads Boutique Women's Consignment Sale, the Consignor has read, and agrees to the following terms and conditions:**

~There is a 250 item limit to all consignors.

~The Consignor is 18 years of age or older

~The Consignor agrees that all items consigned at Scarlet Threads Boutique are theirs to sell.

~ The Consignor understands that the \$15 registration fee is non-refundable if the consignor chooses to withdraw their participation from the sale, or if the event is cancelled early due to circumstances out of STB's control such as weather, fire, power outage, etc.

~The Consignor agrees to allow Scarlet Threads Boutique to sell any accepted items brought to the sale on their behalf.

~It is the responsibility of the Consignor to make sure the items they sell are in excellent condition and "ready to wear." Items should be current styles (purchased in the last three years).

~The Consignor understands and agrees that Scarlet Threads Boutique is an upscale event and reserves the right to reject any item that does not meet their standards.

~The Consignor agrees all items brought to the sale, are in compliance with the guidelines and requirements of the U.S. Consumer Product Safety Commission.

~ The Consignor understands in order to keep a good consigning standing with Scarlet Threads Boutique, consignor must sell at least 25% of items brought in. Consignment events are a learned skill, so after 2 sales if a consignor's sell through percentage has not improved, the consignor will not be permitted to sell with Scarlet Threads Boutique.

~As a Consignor of Scarlet Threads Boutique, you agree not to open a women's consignment event 60 miles from Redlands.

~The Consignor understands that Scarlet Threads Boutique will do everything possible to prevent loss, damage, or theft, but in the case such an event occurs, the Consignor does not hold Scarlet Threads Boutique liable for the loss, damage, or theft of any items, and will make no claims against Scarlet Threads Boutique, AmberLee Goltry, Diane Schaefer, or any volunteers involved at the event. Any items found without a tag will be held in a Lost and Found area. At the end of the sale consignors may examine the area for their lost item(s). Any unclaimed "Lost and Found" items will be donated to charity.

~The Consignor agrees that no claims will be made against Scarlet Threads Boutique, AmberLee Goltry, and Diane Schaefer, for any discrepancies, involving merchandise consigned at the sale.

**~The Consignor understands they will receive 60% of the total sales of their merchandise. If the Consignor chooses to volunteer and meets the requirements of (1) three hour shift, they shall receive 65% of their sales. Consignors that volunteer (2 or more) three hour shifts, shall receive 70% of their sales. If the Consignor signs up to volunteer, but does not follow through with the commitment, they shall receive 60% of their sales, and will be issued a \$10 fee for each volunteer shift missed. This fee will be taken from their consignor earnings. Consignor agrees that the remaining percentage will be paid to Scarlet Threads Boutique in consideration for its work and services in coordinating, organizing and promoting the sale and providing a venue in which such sale may occur.**

~Consignor agrees that any item marked "yes" for discount, will be sold at 50% of original asking price on the designated discount day.

~Consignor understands in order to receive an extra 5% of their sales, they must check DONATE ALL before printing tags. All items brought to the sale MUST have a tag with the donation symbol to qualify for the extra percentage.

~Any unsold merchandise that is not picked up on the specified date, during specified pick up times, will be donated to charity. Scarlet Threads Boutique is not responsible for storing any items after a sale.

~ Consignor understands that Scarlet Threads Boutique is NOT accepting Home Décor items for donation. Any home décor item(s) that are not picked up on the specified date during specified pick up times, there will be a \$50 disposal fee that will be deducted from their earnings and items will be donated to a charity chosen by Scarlet Threads Boutique and are no longer the responsibility of STB.

~ **Scarlet Threads Boutique will promptly mail the Consignor their earnings within two weeks of the close of the sale. Consignor agrees to cash check within 90 days of the issue date, and understands that any check not cashed within 90 days will no longer be valid. Any uncashed checks will be turned over to the state of California after 90 days and will be out of Scarlet Threads Boutique's control. Scarlet Threads Boutique will NOT re-issue checks after 90 days. If consignor loses or damages their earnings check and needs a new check issued, consignor understands that a \$35 reissue fee will be deducted from their check.**

~The Consignor releases and holds harmless, Scarlet Threads Boutique, AmberLee Goltry, Diane Schaefer, and volunteers, of all liability with regard to any physical or emotional harm that may result from participation in the Scarlet Threads Boutique event.
